- 2. Please ensure that you are submitting your offer for the item you really deal in. The specifications / Brand name should be quoted from our list unless you have exactly the same item as per our requirement noted in **FORM B**.
- 3. The rate that you would mention against an item should be the bare cost exclusive of Taxes/customs / excise duty / VAT/ GST etc.

- 15. Each item offered against this NIT shall have a minimum warranty period of 3 years. Tenderer should submit a written guarantee/warranty from the manufacturers stating that the Items being offered is the latest model as per the specifications.
- 16. Guarantee/Warranty Certificate must be provided, at the time of supply.
- 17. All the conditions contained in the Mandatory Statement of Terms & Conditions attached as Annexure-C shall be complied by the bidder. The conditions indicated at Term No. 17 (Earnest Money Deposit & Performance Guarantee) shall have to be particularly complied with.
